- 1. That I am working as Officer on Special Duty, Urban Development Department, State of Jharkhand and as such aware of the facts and circumstances of this case, based upon the records maintained in my office with respect to the present matter and duly authorized to affirm this affidavit.
- 2. That in compliance of the directions issued by this
 Hon'ble Tribunal vide its order dated 13.07.2015, State of
 Jharkhand has filed two affidavits dated 03.08.2015 on
 behalf of Principal Secretary, Urban Development



Department and Principal Secretary, Forest and Environment Department.

- 3. That the Urban Development Department, Government of Jharkhand has taken following steps after filing the aforesaid affidavits.
- 4. That in 22 ULBs, land has been identified and in remaining 19 ULBs land procurement/acquisition is under process. A video conferencing was organized to stress upon the importance of Land availability and understand the problem being faced by the ULBs by Director SUDA on 24th August, 2015.
 - 5. That a meeting was held by the Director (SUDA) with RCUES, the consultant, for reviewing the progress of preparation of DPR in 23 ULBs and to expedite the DPR preparation work.
 - 6. That M/s Essel Infra Projects Ltd., Essel Utilities
 Distribution Pvt. Ltd and Hitachi Zosen India Pvt. Ltd.
 Consortium has been engaged by Ranchi Municipal
 Corporation for collection, Transportation and disposal of
 solid waste in the capital city of Ranchi.

That Girdih SWM project has been technically approved at an approximate cost of Rs.170 Crores and is under the process to grant administrative sanction.

- 8. That Pakur, Sahebganj and Rajmahal SWM projects are under technical sanction process.
- That DPR for Chakuliya Project is likely to be submitted by the consultant by end of September, 2015.
- 10. That rules for user charges for SWM services from residential, commercial and institutional premises in urban areas are being finalized.
- 11. That as submitted earlier vide affidavit dated 03.08.2015 at para 15 read with Annexure B, DPR for remaining ULBs are being prepared and timelines for date of award of work and commissioning of the scheme will be met.
- 12. That a detailed report is being prepared for existing and required infrastructure and human resources in all ULBs to implement door to door collection of waste.
