- 4. That it is respectfully submitted that the State of Bihar is ready to comply with the proposal to stop development activities around the site and to allocate a proper buffer zone for the municipal waste site in the Zonal/Master Plan which will be incorporated at the time of preparation of Zonal/Master Plan.
