AFFIDAVIT ON BEHALF OF STATE OF JHARKHAND

I, Amaresh Kumar Sinha aged about 61 years, R/o 651, Plot # 5, Sector # 7, DWARKA, New Delhi- 110075, working as Officer on Special Duty, Urban Development Department, Government of Jharkhand, do hereby solemnly affirm and declare as under:-

1. That I am working as Officer on Special Duty, Urban Development Department, State of Jharkhand and as such aware of the facts and circumstances of this case, based upon the records maintained in my office with respect to the present matter and duly authorized to affirm this affidavit.

2. That this Hon'ble Tribunal, vide its order dated 16.12.2015, has directed all the States to react to the prayer no. 2 which is related to no open dumping of MSW and other waste to prevent Methane emission and should be strictly in accordance with the MSW Rules; and prayer

no. 3 which is related to Development activity around the site should be stopped and there should be a proper buffer zone for MSW site in the Zonal/Master plan itself.

3. That present affidavit is being filed by the State of Jharkhand in compliance of the aforesaid order of this Hon'ble Tribunal.
4. That the improper dumping is, gradually and systematically, under replacement with scientific & modern land filling site along with integrated solid waste management. To this effect following steps are taken:
 - a. Ranchi Municipal Corporation the work is allotted to the concessionaire. The Consortium of Ms. Esselinfra projects limited, M/s Essel Utilities Distribution Company Private Limited and M/s Hitachi Zosen India Private Limited. An agreement is signed on 30.10.2015 between Ranchi Municipal Corporation and Ranchi MSW Private Limited and the above concessionaire.
 - b. Giridih Nagar Parishad DPR is technically sanctioned and is under process of administrative sanction.
 - c. Pakud Nagar Parishad, Chakulia Nagar Panchayat, Sahebganj Nagar Parishad & Rajmahal Nagar Panchayat DPR are prepared and is under the process of technical sanction.
 - d. For remaining Urban Local Bodies it is under process.



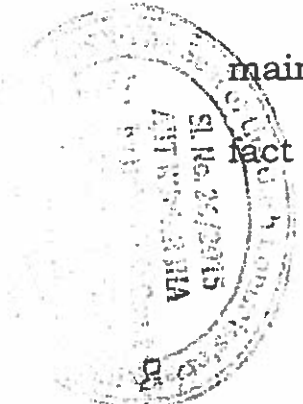
