I, the above named deponent, do hereby, solemnly affirm and state as under:

 That the Hon'ble National Green Tribunal was pleased to pass an order dated 12.01.2017 in the above mentioned case, the relevant extract of which is reproduced below for kind perusal and reference.

"We direct issuance of Notice to show cause to all the State Governments/Union Territories as to why the Tribunal should not pass directions requiring authorities to strictly adhere to doctrine of sustainable development in its true spirit. Why any development project, industrial, residential and commercial be directed not to commence its work until and unless development plan duly provide for collection, processing and disposal of municipal solid waste in accordance with law. It also provides for ensuring that the sewage and other effluents discharged from the complexes does not contain excess in pollution and to ensure that its effluent is not violative of the prescribed parameters".

- 2. The Board has already issued instructions to the concerned Departments to ensure the that no such development project shall commence its work until and unless development plan duly provide for collection, processing and disposal of municipal solid waste in accordance with law.
  - 3. That in compliance to the orders dated 12.01.2017 of this Hon'ble Tribunal as explained above, the Punjab Pollution Control Board has issued necessary directions to all its offices to comply with the directions/orders of

the Hon'ble National Green Tribunal in letter and substance. Copy of letter so issued is placed at **Annexure-A** for kind perusal of this Hon'ble Tribunal.

- 4. That the Department of Local Government, Department of Housing and Urban Development and Punjab Municipal Infrastructure Development Company, which are dealing with development projects, have been requested by the Punjab Pollution Control Board to ensure that no development project shall commence its work until and unless development plan duly provides for collection, processing and disposal of municipal solid waste in accordance with law. The above departments have also been requested to ensure that the sewage and other effluents discharged from the complexes is not violative of the prescribed parameters. Copy of letter so issued is placed at **Annexure-B** for kind perusal of this Hon'ble Tribunal.
- 5. That the Department of Local Government, Punjab; Punjab Municipal Infrastructure Development Company has submitted that they have no objection if the above mentioned order is passed by Hon'ble National Green Tribunal. Copy of letter placed at **Annexure-C.**
- 6. That the Department of Housing and Urban Development has submitted that their department takes appropriate action on the orders which are passed by the Hon'ble National Green Tribunal. Copy of letter placed at **Annexure- D.**


