**COMPLIANCE AFFIDAVIT BY THE JHARKHAND STATE
POLLUTION CONTROL BOARD**

1. That I am working as Board Analyst in the Jharkhand State Pollution Control Board i.e. the answering respondent and as such I am well conversant with the facts of the circumstances of the case and as such competent to swear the present affidavit.
2. That I have gone through the contents of the attached present affidavit and state that the same are true and correct on the basis of the information derived from the record maintained in the office of the respondent.
3. That Board is constantly pursuing the urban local Bodies for the compliance of the provisions of the Municipal Solid Waste

(Management & Handling) Rules, 2000 and Solid Waste Management Rules, 2016 through letters and with a copy of the letter always marked to the Urban Development Department Govt. of Jharkhand.

4. That Order of the Hon'ble NGT dated 22.12.2016 in the matter of Almitra. H Patel Vs Union of India and Ors (O.A No. 199/2016) has been uploaded on the website of JSPCB.

5. That Board has directed all urban local bodies for the compliance of provisions of the Solid Waste Management Rules, 2016, and the order of the Hon'ble NGT dated 22.12.2016 read with Kudrat Sandhu within stipulated time such as :-

- a. Preparation and submission of solid waste management plan;
- b. Arrangement for door-to-door collection of segregated solid wastes;
- c. Identification and allocation of suitable land for setting up of waste processing and disposal facilities including land fill sites;
- d. Establishment of waste deposition centers for domestic hazardous waste for its safe storage, transportation & disposal;
- e. Setting-up of waste processing, treatment and disposal facility and submission of application for authorization for the same;

- f. Submission of annual report and
 - g. To create public awareness to educate the waste generators.
6. That Board is also pursuing ULBs and Urban Development Department Govt. of Jharkhand, to set up sewage treatment plants and disposal of sewage generated from municipal areas.
 7. That Board has requested CPCB to co-operate the Board for conducting research by monitoring the incidents of open burning and assessments of emitted pollutants of such illegal and unauthorized burning of waste.
 8. That in addition, Jharkhand State Pollution Control Board has also requested to CIMFR, Dhanbad and MECON Ltd., Ranchi to conduct the monitoring of the incidents of open burning and assessments of emitted pollutants of such illegal and unauthorized burning of waste.
 9. That the answering respondent has the highest regards for this Hon'ble Tribunal and is always ready and willing to obey all the guidelines/directions issued by this Hon'ble Tribunal.
 10. That I have gone through the contents of the attached response affidavit and state that the same are true and correct on the basis of the information derived from the record maintained in the office of the respondent/applicant.

11. That the statements made in paragraphs are true to my knowledge and belief, those are true to my information derived from the records of this case and rest is by way of submission before this Hon'ble Tribunal. Annexures are photo/ true copies of their respective originals.
